## Purpose:

In order to abide by the above Regulation, Hertsmere Borough Council as a CIL Charging Authority is required to publish a report for any financial year in which it collects Community Infrastructure Levy known as CIL.

The Council implemented its Community Infrastructure Levy from 1 December 2014.
