- 1) We are currently replacing old desktop Pcs, (approximately 6 years plus) running Windows 7 operating system, with laptop devices. The procurement process included a disposal option and the contractor will be arranging disposal. We are not currently disposing of any laptops.

- 4) In September 2019 a motion was presented to Hertsmere's full Council entitled "Climate Emergency". Since then the following actions have taken place:
 - Climate Change Working Group (Chaired by Portfolio Holder) has been established and met 4/5 times
 - A Climate Change officer was appointed in March 2020
 - A Climate Change Strategy and Action Plan was approved by Executive (July 2020), which included the following key principles:
 - Reduce consumption

- Minimise waste
 - Switch to renewable sources of energy
 - Switch to sustainable transport
 - Sustainable new development
 - Protect and enhance greenbelts, open spaces and biodiversity
 - Implement principles of circular economy
 - Buy and consume local produce
 - Build climate change resilience
