LOCATION

The premises are located on Leeming Road, which forms part of a double parade of shops, together with those on the adjacent Aycliffe Road. In total, the parade comprises 40 shop units of various sizes. The parade is located approximately one mile from Borehamwood town centre and is well served by public transport. The parade is a well used thoroughfare and offers free on-street and off-street parking. Neighbouring retailers include, The Co-op, RS McColls, Labrokes, along with independent occupiers such as an off-licence, hair and beauty salons, fashion boutiques, a butchers, Post Office, bakery, a laundrette and dry-cleaners, a carpet retailer, a stationers, an electrical supplier retailer, restaurants, cafes and takeaways.

DESCRIPTION

The premises comprise a mid-terrace "single unit" ground floor lock-up shop with a WC and washroom. Delivery access is via the rear of the property through a shared communal service yard and occupier parking area.
