Cllr Batten welcomed everyone to the meeting and introductions were made.

Therma-Hydrometers

Andy Chittenden gave an overview of how to control condensation and mould. There are many health related issues such as asthma which can be caused by condensation and mould. Some difficulties include older properties, not keeping heating on due to costs, seasonal problem, and lack of advice.

1000 Therma-Hydrometers were funded through the public health fund to allow residents to manage their own mould and damp. A leaflet is provided with it to help team manage themselves, targeting the elderly and those in private rented accommodation. The key aims are to reduce condensation, cold, mould and there effects on health.

Action: CAB can support with distribution of leaflets or mould detectors as often get enquiries regarding this. Community shop and Community Navigators can also distribute leaflets.

Smokefree Hertfordshire

Rushma Patel and Nick Phipps presented on Smokefree Hertfordshire. Please see attached presentation.

Some Key Priorities for Hertsmere include:

- Smokefree homes and cars – 10 pledges from Hertsmere. Launching this campaign next year though has already begun keen for partners to help promote.
- Routine and manual workers – 26.2%
- Keen to do roadshows in Hertsmere next year.
- Health harms campaign in January (Rolling tobacco/Routine manual workers)
