(RESTRICTION OF WAITING) ORDER 2019**

NOTICE IS HEREBY GIVEN that the Hertsmere Borough Council (pursuant to arrangement made with Hertfordshire County Council) proposes to make the above Order under the Road Traffic Regulation Act 1984. The general effect of the Order would be to introduce waiting restrictions to improve road safety and to reduce instances of inappropriate or inconsiderate parking.
