Hertsmere Borough Council, (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 Local Government Act 2000 and Local Authorities (Arrangements for the Discharge of Functions)(England) Regulations 2000 in exercise of the powers conferred on that County Council under Sections 32, 35, 45, 46, 49 and 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

- This order may be cited as "The Hertsmere Borough Council (Kemp Place and Montague Hall Place, Bushey) (Residents Parking Places) Order 2020 (Amendment No.1) Order 202*" hereinafter referred to as "this Order" and shall come into operation TBC
- 2. The Hertsmere Borough Council (Kemp Place and Montague Hall Place, Bushey) (Residents Parking Places) Order 2020 shall be amended in accordance with Articles 3 to 4 to this Order.
- 3. The sides of road referred to in columns 1, 2, 3 and 4 of the Schedule 1 to this Order shall be added to Schedule 1 of the 2020 Order as are indicated in Schedule 1 to this Order.
- 4. The sides of road referred to in columns 1, 2, 3 and 4 of the Schedule 2 to this Order shall be deleted from Schedule 1 of the 2020 Order as are indicated in Schedule 2 to this Order.
- The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
