**THE HERTSMERE BOROUGH COUNCIL (VARIOUS ROADS, POTTERS BAR)
(CONTROLLED PARKING ZONE) (PARKING PLACES) 2014 (AMENDMENT NO.1) ORDER
2015**

Hertsmere Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 in exercise of the powers on the said County Council by Sections 1, 2, 3, 4, 32, 33, 45, 46, 49 and 53 to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), Part IV of Schedule 9 of the Act of 1984, Regulation 21 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

1. This Order shall may be cited as The Hertsmere Borough Council (Various Roads, Potters Bar) (Controlled Parking Zone) (Parking Places) (Amendment No.1) Order 2015 (hereinafter referred to as "this Order") and shall amend: The Hertsmere Borough Council (Cedar Close, Inglefield and Rosary Court, Potters Bar) (Controlled Parking Zone)(Parking Places) Order 2014 (hereinafter referred to as "the Order of 2014") and shall come into operation on 30th September 2015.

Amendment

2. The Order of 2014 is hereby amended by the inclusion of items in Schedules 1 and 2 of this Order.

Revocation

3. Schedule 1 of the Order of 2014 shall be revoked and replaced by Schedule 1 of this Order.
4. Schedule 2 of the Order of 2014 shall be revoked and replaced by Schedule 2 of this Order.

Interpretation

5. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order, Order of 2014 shall have effect as though items in the schedules of this Order were added or removed from Schedules 1 and 2 and of the 2014 Order.

| Cedar Close | Both Sides | From a point 5 metres south west of the south west kerb line of Mountway south west and westwards for its entire length and including the western extremity. |
| Church Road | South Side | From a point approximately 50 metres east of the eastern kerbline of Church Road junction with Quakers Lane eastwards for a distance of approximately 27metres |
| Church Road | South Side | From a point in line with the common boundary between property numbers 69 and 71 Church Road eastwards for a distance of approximately 9 metres |
| Church Road | South side | From a point approximately 5.5metres east of the common boundary between property numbers 73 and 75 Church Road eastwards for a distance of approximately 6 metres |
| Church Road | South side | From a point approximately 3 metres east of the common boundary between property numbers 79 and 81 Church Road eastwards for a distance of approximately 20 metres |
| Church Road | South side | From a point approximately 8 metres east of the common boundary between property numbers 89 and 91 Church Road eastwards for a distance of approximately 23 metres |
| Church Road | South Side | From a point approximately 2.3 metres east of the eastern boundary of property number 103 Church Road eastwards for a distance of approximately 15 metres |
| Church Road | South Side | From a point approximately 23 metres east of the eastern boundary of property number 103 Church Road eastwards for a distance of approximately 18 metres |

| Inglefield, Church Road (access road to 1 – 7 Church Road) | Both Sides | From a point 10 metres south of the southern kerb line of Church Road southwards and westwards to the extremities of Church Road (service road) and Inglefield, and including both extremities. |
| Rosary Court | Both Sides | From points 8 metres south of the southern kerb line of Church Road on both the west and east accesses southwards for its entire length and including the southern extremity. |
