# Annex 1 - Mandatory Conditions

There shall be no alteration of the rules of the club relating to the sale of alcohol without the consent of the Licensing Authority.

## Annex 2 - Conditions consistent with the operating schedule

Only members and guests shall be permitted on the premises.

Members and guests shall comply with the rules of the club.

CCTV and Fire Extinguishers must be maintained and in full working order.

Persons under the age of 18 years shall only be permitted on the premises if accompanied by an adult member or guest.

In relation to persons thought to be under the age of 18, I.D. must be required and if not provided or if there is any doubt about the I.D. then the service of alcohol must be refused.

Prominent, clear and legible notices shall be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.

The placing of bottles into receptacles external to the premises must not take place between 21:00 hours and 09:00 hours.

Ingress and egress notwithstanding, all external doors and windows to the premises shall be kept closed during regulated entertainment that involves amplified music and/or voices.

All external doors shall be fitted with automatic door closers. Where an external door is served by a lobby, the door closer may be fitted to the internal lobby door.

Fire exits shall be kept illuminated and clear of any obstruction.

The electrical installation shall be inspected at least once in every five years, or such lesser period as is considered appropriate to the individual case, by a competent electrical engineer appointed by or on behalf of the licensee of the premises and a certificate stating the condition of the installation shall after each inspection, be forwarded to the Council by or on behalf of the licensee of the premises.
