Annex 1 - Mandatory conditions

All supplies of alcohol

1. No supply of alcohol may be made under the premises licence-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
All embedded restrictions and conditions inherent in the Licensing Act 1964.

Alcohol shall not be sold in an open container or be consumed in, the licensed premises.

Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours means:

- a. On weekdays, other than Christmas Day, 08:00 until 23:00.
- b. On Sundays, other than Christmas Day, 10:00 until 22:30.
- c. On Christmas Day, 12:00 until 15:00 and 19:00 until 22:30.
- d. On Good Friday, 08.00 until 22:30.

The above restrictions do not prohibit:

- (a) the taking of the alcohol from the premises, (unless the alcohol is supplied or taken in an open vessel,) during the first twenty minutes after the above hours;
- (b) the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered;
- (c) the sale of alcohol to a trader or club for the purposes of the trade or club;
- (d) the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces.

Mandatory licence condition imposed by The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010

Age verification policy

1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or
 - (b) an ultraviolet feature.

Permitted price

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula

$$P = D + (D \times V)$$

where :

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) “relevant person” means, in relation to premises in respect of which there is in force a premises licence

- (i) the holder of the premises licence.
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) “relevant person” means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) “value added tax” means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day (“the first day”) would be different from the permitted price on the next day (“the second day”) as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 3 Conditions attached after hearing by the licensing authority.

1. Between the hours of 15.00 hours and close of business each day, a Personal License Holder shall be on the premises. This condition will not apply in the event of exceptional or unforeseen circumstances. This condition shall take effect 21 days from the date of the hearing. An exceptional circumstance does not include planned absences or holiday.
2. A Challenge 25 Policy shall be adopted at the premises. Any person who appears to be under the age of 25 will be asked to provide proof of evidence of age. The only form of proof of age to be accepted to be passport, photographic driving license or PASS approved ID card.
3. Every member of staff who deals with sales shall receive training in PASS card recognition.
4. The premises must install an electronic till which automatically prompts staff to check the age of the buyer when age restricted products are entered for sale into the till. This condition shall take effect 21 days from the date of the hearing.
5. A training record shall be made and retained for all staff of training in relation to age restricted products, PASS card recognition, refusal books and till prompts. These records must be made available to Police Officers (including Community Support Officers and Police Licensing Officers) Licensing Authority staff and Training Standards staff on request.
6. A refusal book shall be used. Every time an underage or proxy sale is refused an entry shall be made which will record the time and date of the refusal, reasons for the refusal and personal details (name and address) of the refused customer if known. If not known a physical description, which will include approximate age, gender, ethnic appearance and clothing worn will be recorded.
7. The refusal book shall remain on the premises at all times and produced to Police Officers (including Community Support Officers and Police Licensing Officers), Licensing Authority staff and Training Standards staff.
8. Signs shall be displayed at the entrance, alcohol display and point of sale warning against under age and proxy sales and identifying what types of ID are accepted at the premises and highlighting the Challenge 25 policy.
9. The premises shall display literature including application forms promoting the Validate proof of age card, such as PASS cards, whilst in existence.
10. A Premises License Holder shall attend any future age check seminars arranged by Hertfordshire Trading Standards, within the next 12 months, or as soon as possible thereafter.
