**Annex 1 - Mandatory conditions.**

No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

**Annex 2 - Conditions consistent with the operating schedule.**

1. (a) A CCTV system shall be installed and maintained in full operational order. It shall include coverage of the clubhouse, car park and surrounding area.

(b) Recordings shall be kept securely at the premises for at least 30 days and shall be produced on request to the police, police community support officers and licensing authority.

2. All functions shall be pre-booked.

3. The level of noise emitted from the site shall not exceed the background noise level at any time as measured at the boundary of the nearest noise sensitive premises, measured as a 15-minute average A-weighted decibel noise level. Peak noise levels must not exceed the background noise level at any time by more than 10 dB(A).

4. Children shall only be permitted on the premises after 16:00 while accompanied by a responsible adult.
