## Annex 1 - Mandatory conditions.

Where a programme includes a film in the 12A, 15 or 18 category of the British Board of Film Classification, no person appearing to be under the age of 12 (and unaccompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme; and the licence holder shall display in a conspicuous position a notice in the following terms: -

Persons under the age of (insert appropriate age) cannot be admitted to any part of the programme.

Where films of different categories form part of the same programme, the notice shall refer to the oldest age restriction. This condition does not apply to members of staff under the relevant age while on duty provided that the prior written consent of the person's parents or legal guardian has first been obtained.

## Annex 2 - Conditions consistent with the operating schedule.

The premises shall be manned by security 24 hours per day.

## Annex 3 - Conditions attached after hearing by the licensing authority.

- 1. Ingress and egress not withstanding, all external doors and windows to the premises shall be kept closed during any regulated entertainment.
- 2. All external doors shall be fitted with automatic door closers. Where an external door is served by a lobby, the door closer may be fitted to the internal lobby door.
- 3. Prominent, clear and legible notices shall be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.
- 4. Ventilation ducts through external walls facing noise-sensitive premises within 100 metres shall be acoustically treated.
- 5. All external doors shall be fitted with acoustic seals and threshold strips.
- 6. A noise-limiting device shall be used for regulated entertainment that involves amplified music and/or voice. The device shall be fitted and set in conjunction with and to the satisfaction of the Environmental Health Unit.
- 7. For the first year of the licence the premises licence holder shall be required to hold one meeting per academic term with the residents, and thereafter meetings shall be held as and when deemed necessary by either party. A Ward Councillor shall be invited to each of the meetings.

- 8. 12 events shall be permitted for each academic year, of which up to three can be held on a Sunday. A maximum of four of the events may be open air events, only one of which may exceed 20.00 hours.
- 9. All vehicles in the premises' car park shall be parked in a manner so as to prevent public nuisance.
- 10. A calendar of all the premises' forthcoming events shall be provided to the Council's Licensing Officer, by 30 September each year.
