No supply of alcohol may be made under this licence

1. At a time when there is no designated premises supervisor in respect of it or,
2. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating schedule.

Intoxicating liquor shall not be sold or supplied on the premises otherwise than to a person taking table meals there and for consumption by such a person as ancillary to his meal.

Suitable beverages other than intoxicating liquor including drinking water shall be equally available for consumption with or otherwise as an ancillary to meals served in the licensed premises.

If anyone is misbehaving or intoxicated then service of alcohol must be refused.

An adult must accompany children.

No adult entertainment will be supplied.

Agreed Conditions.

Ingress and egress notwithstanding, all external doors and windows to the premises are to be kept closed during and regulated entertainment.

All external doors are to be fitted with automatic door closers. Where an external door is served by a lobby, the door closer may be fitted to the internal lobby door.

Amplified music and/or speech external to the premises is not permitted.

Prominent, clear and legible notices are to be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.

Loudspeakers used for regulated entertainment (other than background music) that are mounted on walls or ceilings must be acoustically isolated from the building structure.
