Annex 1 - Mandatory conditions.

Where a programme includes a film in the 12A, 15 or 18 category of the British Board of Film Classification, no person appearing to be under the age of 12 (and unaccompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme; and the licence holder shall display in a conspicuous position a notice in the following terms: -

Persons under the age of (insert appropriate age) cannot be admitted to any part of the programme.

Where films of different categories form part of the same programme, the notice shall refer to the oldest age restriction. This condition does not apply to members of staff under the relevant age while on duty provided that the prior written consent of the person's parents or legal guardian has first been obtained.

Annex 2 - Conditions consistent with the operating schedule.

1. Proposed events shall be approved by the Safety Advisory Group of Hertsmere Borough Council ("the Council").
2. Notices of intended events shall be displayed at the entrances to the park prior to the event providing the address and telephone number of the organiser.
3. Stewards shall be employed to discourage crime and disorder and promote public safety. Hertfordshire Constabulary shall be provided with notice of intended events. Police Community Support Officers shall be invited to attend.
4. During the entire event at least 1 officer of Hertsmere Borough Council shall be present to assist the public with any complaints of public nuisance, amongst other duties.
5. A first aid tent or other shelter shall be erected staffed by qualified first aiders where appropriate.

RCD circuit breakers shall be fitted to electrical apparatus.

7. Only persons whose backgrounds have been approved by the Council shall be permitted to work in close proximity with or supervise children and only in teams of at least 2 such persons.

Annex 3 - Conditions attached after hearing by the licensing authority.

1. The Parks Department should consult with Environmental Health with regard to toilet provision during regulated entertainment.
2. The Parks Department should consult with the residents of Perry Mead and the Friends of King George Recreation Ground to try and resolve anti-social behaviour problems identified behind the disused changing rooms.
