Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating schedule.

Alcohol must only be sold to seated patrons in the restaurant area.

Driving Licence, Passport or Passcard will be the only accepted proof of age.

Water must be available in equal quantities to alcohol.

The immediate area outside the premises must be kept in an orderly and tidy manner.

Children must be accompanied by an adult except when ordering from the take away section of the business.
