#### Annex 1 - Mandatory Conditions

There shall be no alternation of the rules of the club relating to the sale of alcohol without the consent of the Licensing Authority.

All embedded restrictions and conditions inherent in the Licensing Act 1964.

Ingress and egress not withstanding, all external doors and windows to the premises are to be kept closed during any regulated entertainment.

All external doors are to be fitted with automatic door closers. Where an external door is served by a lobby, the door closer may be fitted to the internal door. (Except fire exit only doors fitted with a break bar).

Prominent, clear and legible notices are to be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.

Amplified music and/or speech external to the premises is not permitted.

The tipping of bottles into receptacles external to the premises must not take place between 21:00 and 09:00 hours.

The use of areas external to the premises for the consumption of alcohol, other refreshment or food, must cease by 23:30 Monday to Saturday and 23:00 on Sunday.

# Annex 2 – Conditions consistent with the operating schedule

To persons thought to be under the age of 18, I.D must be required and if not provided or in any doubt of the I.D then the service of alcohol must be refused.

The 24 hour security system must be fully operational and maintained.

Staff must have Fire, Electrical, First Aid and Health & Safety training.
