**Annex 2 – Conditions consistent with the operating schedule**

The shutters must be kept shut when premises is not in use.

Alarm system must be maintained and in full working order.

Inspections of the electricity, gas and fire equipment must be maintained to their full working order.

All staff must have a criminal background check by the Police.

To persons thought to be under the age of 18, I.D must be required and if not provided or in any doubt of the I.D then the service of alcohol must be refused.

Must continue being an active member of Pubwatch.

The premise is only open to members and guests of the club.

All bar staff must undergo Criminal Record Bureau clearance.

### **Annex 3 – Conditions attached after hearing by licensing authority**

1. Ingress and egress notwithstanding, all external doors and windows to the premises are to be kept closed during any regulated entertainment.
2. All external doors are to be fitted with automatic door closers. Where an external door is served by a lobby, the door closer may be fitted to the internal lobby door.
3. Amplified music and/or speech external to the premises are not permitted.
4. Prominent, clear and legible notices are to be displayed at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.
5. The tipping of bottles into receptacles external to the premises must not take place between 21:00 hours and 09:00 hours.
6. The use of areas external to the premises for the consumption of alcohol, other refreshment or food, must cease by 23:00 Monday to Saturday and 22:30 Sunday.
7. The capacity of the premises shall be set at 120 persons.
8. Children under 14 years of age are not permitted on the premises after 21:00 hours Sunday to Thursday and after 23:00 Friday and Saturday.
9. There shall be no change in the club's rules in relation to the sale of alcohol without the prior approval of the Licensing Authority.
