### **Annex 2 – Conditions consistent with the operating schedule**

Only members and guests shall be permitted on the premises.

Prominent, clear and legible notices shall be displayed at all exits requesting the members and guests to respect the needs of local residents and to leave the premises and the area quietly.

The Club shall ensure that noise does not emanate from the premises so as to cause a nuisance to nearby properties.

Persons under the age of 18 years shall only be permitted on the premises if accompanied by an adult member or guest.

In relation to persons thought to be under the age of 18, I.D must be required and if not provided or in any doubt of the I.D then the service of alcohol must be refused.
