## **Annex 3 – Conditions attached after hearing by licensing authority**

Ingress and egress notwithstanding, all external doors and to the premises are to be kept closed during any regulated entertainment.

That all doors are to be fitted with automatic door closers. Where an external door is served by a lobby, The door closer may be fitted to the internal lobby door.

Save for sporting events, amplified music and/or speech external to the premises is not permitted.

Prominent, clear and legible notices are to be displayed at all exits, including the junction with the access road and the car park exit and the junction with Cobden Hill, requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.

The tipping of bottles into receptacles external to the premises must not take place between 21:00 and 09:00 hours.

The use of areas external to the premises for the consumption of alcohol, other refreshment or food, must cease by 23:00 Monday to Saturday and 22:30 on Sunday.

Ventilation ducts through external walls facing noise-sensitive premises within 100 metres must be acoustically treated.

Secondary or double-glazing is required for single glazed windows facing noise-sensitive premises within 100 metres.

Noise from regulated entertainment should not be audible at any nearby noise-sensitive premises.

**No children under 16 years of age are to be allowed on the premises after 21:00 on any day unless they are attending family events, quiz nights or presentation evenings.**
