Annex 1 - Mandatory conditions.

Where a programme includes a film in the 12A, 15 or 18 category of the British Board of Film Classification, no person appearing to be under the age of 12 (and unaccompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme; and the licence holder shall display in a conspicuous position a notice in the following terms: -

Where films of different categories form part of the same programme, the notice shall refer to the oldest age restriction. This condition does not apply to members of staff under the relevant age while on duty provided that the prior written consent of the person's parents or legal guardian has first been obtained.

1. Admission shall be limited to persons who have been issued with tickets prior to the date of the performances. Entrances shall be supervised by teachers or parent supervisors.
2. School policies and procedures shall be applied in promoting the licensing objectives of protecting children from harm and preventing public nuisance.
