Annex 1 - Mandatory conditions.

1. No supply of alcohol may be made under this licence

- (i) At a time when there is no designated premises supervisor in respect of it or,
- (ii) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

2. Where a programme includes a film in the 12A, 15 or 18 category of the British Board of Film Classification, no person appearing to be under the age of 12 (and unaccompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme; and the licence holder shall display in a conspicuous position a notice in the following terms: -

Persons under the age of (insert appropriate age) cannot be admitted to any part of the programme.

Where films of different categories form part of the same programme, the notice shall refer to the oldest age restriction. This condition does not apply to members of staff under the relevant age while on duty provided that the prior written consent of the person's parents or legal guardian has first been obtained.

Annex 2 - Conditions consistent with the operating schedule.

1. A fire risk assessment and plan for any temporary structures such as marquees used for events shall be supplied to the Hertfordshire Fire and Rescue Service prior to its use.

2. A suitably qualified and experienced acoustic consultant shall be employed to formulate a plan to prevent public nuisance due to noise, the plan to be agreed by the Environmental Protection Team. The plan shall be completed by 1st July 2009 and reviewed after the first marquee event and revised if necessary to the satisfaction of the Environmental Protection Team. It shall thereafter be reviewed at the request of the Environmental Protection team.

3. Suitable staff shall be trained in the use of a sound level meter and records of such training kept.

4. When events are taking place after 23:00 hours a competent member of staff shall patrol the boundary of the estate paying particular attention to those areas near to noise sensitive premises, checking the noise level of events. Such patrols to take place no less than once per hour. Records of such monitoring shall be kept and made available for inspection as required.

5. All events finishing after 02:00 hours to be notified to the Licensing Authority in writing no less than 10 days before the event.

6. The name and contact telephone number of a suitable person shall be provided to the Licensing Authority at least 7 days before any marquee based event.

7. Persons under the age of 16 years shall only be permitted on the premises while in the care of a responsible adult.

8. On no more than 6 occasions a year, hours may be extended for E,F,H,I,J,K and L until 04:30 and the premises may remain open to the public until 05:30. These occasions are to be notified to the Licensing Authority no less than 10 days prior to the event.
