Annex 1 - Mandatory conditions.

- 1. No supply of alcohol may be made under this licence
 - 1) At a time when there is no designated premises supervisor in respect of it or,
 - 2) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

2. Where a programme includes a film in the 12A, 15 or 18 category of the British Board of Film Classification, no person appearing to be under the age of 12 (and unaccompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme; and the licence holder shall display in a conspicuous position a notice in the following terms: -

Persons under the age of (insert appropriate age) cannot be admitted to any part of the programme.

Where films of different categories form part of the same programme, the notice shall refer to the oldest age restriction. This condition does not apply to members of staff under the relevant age while on duty provided that the prior written consent of the person's parents or legal guardian has first been obtained.

Annex 2 - Conditions consistent with the operating schedule.

- 1. Security officers shall be on site during all opening hours
- 2. Events shall not be open to the general public: admission shall be by way of invitation only.
- 3. The capacity of the Dining Hall shall not exceed 250 persons.
- 4. The capacity of the Sports Hall shall not exceed 300 persons unless an additional fully maintained emergency exit light is fixed above the entrance storage area and a 1500mm wide clear path is established in that storage area to the external fire door: in this case 400 persons may be permitted.
- 5. The Assembly Hall shall not be used for any licensable purpose until it is inspected by Hertfordshire Fire and Rescue Service and a capacity figure agreed.
