**Hertfordshire County Council (Aldenham 95 & 96 and Elstree & Borehamwood 64 & 65)  
Modification order 2017**

The above Order was made on 18<sup>th</sup> August 2017 and was advertised for the statutory period of 42 days. This Order has now been confirmed without modifications by an inspector following written representation and we are now serving you with notice of this.

Please find enclosed the following:

The effect of the Order as confirmed is to modify the Definitive Map and Statement by adding to them a Footpath running from the junction between Aldenham footpath 52 and Elstree & Borehamwood footpath 1 on the parish boundary at TQ 1669 9585 running in a generally south-westerly direction across the grass between the car park and the north-west side of Aldenham Reservoir for approx. 170m to the edge of the woodland at TQ 1659 9572. Continuing in a generally southerly then easterly direction within the woodland, past the children's play area, for approx. 290m to TQ 1679 9557. Continuing in a southerly direction on the west side of Aldenham Reservoir for approx. 170m to TQ 1676 9540 and then in a generally west and north-westerly direction for approx. 180m to TQ 1660 9546. Continuing in a generally north-west then south-west direction adjacent to paddocks at Aldenham Country Park for approx. 140m to TQ 1652 9540. Continuing in a south and south-easterly direction for approx. 250m to cross the bridge at TQ 1672 9530 and continuing in a generally south-easterly then southerly direction for approx. 200m to TQ 1679 9514 then in a generally east-north-easterly direction on the south side of Aldenham Reservoir, parallel to A411 Watford Road for approx. 430m to a junction with Elstree & Borehamwood footpath 5 at TQ 1716 9525..

It is possible for anyone to question the validity of an order by making an application to the High Court within 42 days from the date of the publication of this confirmation. The grounds on which an appeal can be made are specified in paragraph 12 of Schedule 15 of the Wildlife and Countryside Act 1981.

For a challenge to be successful, the person making the appeal would have to show that:

- The legislation was not applied correctly when confirming this Order; or
- The County Council has not followed the required legal procedures
