### **Site Allocations and Development Management (SADM) Policies Plan – Submission to Secretary of State. Notification under Regulation 22(3) and Regulation 24 of the Town and Country Planning (Local Planning) (England) Regulations 2012**

On 16 November 2015 the Council submitted the Site Allocations and Development Management (SADM) Policies Plan to the Secretary of State, under Regulation 22 of The Town and Country Planning (Local Planning) (England) Regulations 2012, for Examination by an independent Planning Inspector.

Mr John Mattocks BSc DipTP MRTPI FRGS has been appointed as the Inspector for the SADM Policies Plan.

An independent Programme Officer, Ms Helen Wilson, has also been appointed to manage the administrative arrangements for the Examination on behalf of the Inspector. The Inspector has indicated that the Examination hearing will commence at 9.30am on Tuesday 16 February 2016 at the Civic Offices, Elstree Way, Borehamwood. It will be held over several days. The Programme Officer will be writing to all representors in due course and will send them the Inspector's procedural note and a copy of the draft programme with the Matters, Issues and Questions to be examined.
