**Page 53, para. 7.11**

Hertsmere Borough Council (HBC) says that the Paddock must be protected because there is a general deficit of parks and gardens in Bushey. This is not true. HBC fails to acknowledge the beautiful 2 acre garden at Reveley Lodge, open to the public Monday to Friday and located opposite the Paddock that is not open to the public. Warren Lake and Mary Forsdyke Gardens are located nearby and open to the public every day. In addition residents close to the Paddock have open access to Stanmore Common at the end of Clay Lane, seven days a week. More importantly HBC has failed to acknowledge Hillmead Nature Park, Bushey Heath, comprising of 3.21 acres which they manage as an HBC wood and open to the public. There is no shortage of open spaces in Bushey Heath and therefore their scoring for *Amenity benefits and sense of place* does not make sense and is unsound.

**Page 54, para. 7.13**

It is untrue that *'the Paddock represents a last remaining part of the heath'* as HBC claims. *'Bushey Heath'* is a place name, originating as a name of a hamlet that was located close to the Herts County boundary where it meets the Middlesex County boundary, dating back to the 12th century. Overtime this place name has come to mean a much bigger area as we know it today, encompassing the land near the Paddock. The term *'heath'* has been in this context incorrectly used, making the HBC assertion unsound.

**Page 54, para. 7.13 and BHRA 059, page 1, Note 1**

It doesn't make sense to say that the Paddock is the last remaining part of *'common land'* as claimed by Bushey Heath Residents Association (BHRA). *'Common land'* means: *a term applied to manorial waste land over which common pasture rights existed as part of the Feudal System. Once this land goes into private ownership all rights are erased. The Paddock has never been common land and has been in private ownership for at least 400 years. No member of the public can access this field in the context of 'common land' today. Therefore to state that the Paddock is the last remaining site of 'common land' in Bushey Heath is unsound.*

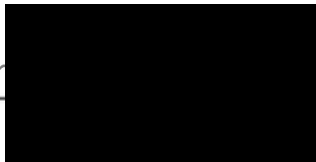
