The Council's Open Space Study (Document EB25, Chapter 6)' indicates that there is a general deficit of Parks and Gardens provision in the Bushey area which adds to the importance of the site as an existing open space in the area.' This statement is unsound as it is clear that this area of Bushey Heath is not short of open spaces as Reveley Lodge Gardens are directly opposite. (See attached aerial view.) Reveley Lodge has been visited by hundreds of local children over the last few years as part of the Bushey Museum Education program. It is open every weekday and casual visitors drop in regularly as do art and gardening groups. The Paddocks in contrast is, as the Council states, 'not necessarily or currently freely accessible to the general public,' and is not visited regularly by the wide variety of Bushey residents that visit Reveley Lodge.

The Green Spaces and Amenity Land Report 2012 page 10 looks at the reasons for preserving local green spaces. These suggest two categories as follows *'Cultural and Heritage*

Some Green spaces have a historical value- Historic buildings or Historic gardens-symbol of the area.

Amenity benefits and sense of place, helps to create a specific neighbourhood, provides an important landmark, clearly visible from most areas'.

It is Reveley Lodge that provides both the historical context and the local landmark rather than the Paddocks. The Paddocks is not clearly visible from the surrounding area because of the thick hedges and trees around it. As the Bushey Heath Residents point out in their submission, it is the house and garden party that attracted hundreds of local people every year page 5 BHRA, not the Paddocks.
