Summary

The annual Local Sites Ratification Meeting was held on 22 November 2012, between Hertfordshire Biological Records Centre, Herts & Middlesex Wildlife Trust and Natural England

The panel revisited the issue of old species data, particularly for amphibian and reptile LWS, where recent data is absent or difficult to obtain. A number of species LWS have been de-selected this year for this reason. Unfortunately, changing priorities to LRC workload (due to preparing for its transfer to a new host) meant there was no time to address Bat LWS this time round.

Work continues to assess, de-select and re-map species Local Sites. Related queries raised throughout the year will be discussed at the next annual Ratification meeting in late 2013.

There were a number of boundary amendments, name changes and filecode (site reference) changes and this information is available in the March 2013 GIS layer.

There were:

- **2** new Local Wildlife Sites
- **96** de-selected Local Wildlife Sites.
- **0** RIGS were selected or de-selected.

- The figures in this table represent the exact numbers and areas of Local Sites in Hertfordshire, and within each District.

- All overlapping sites have been ‘clipped’ to the District boundaries to split the sites, resulting in an accurate reflection of the area within each District.
- The areas will continue to vary from year to year with the addition and de-selection of sites, as well as major boundary amendments. Throughout the year, there are also numerous minor changes to boundaries as new information becomes available (e.g. the removal of areas with no ecological value). Re-digitising is also necessary when Ordnance Survey baseline mapping data is updated, and we continue to use Master Map to improve non-statutory site boundaries.
