## Notification under section 49 of the Communications Act 2003

- 1. On 6 December 2016, Hertsmere Borough Council, in accordance with section 49(4) of the Communications Act 2003 ('the Act'), issued a notification setting out its draft decision in response to a proposal by British Telecommunications plc for the removal of public call boxes pursuant to Part 2 of the Direction ('the First Notification').

On The Green The Green Letchmore Heath Watford  Object  1. The payphone was used for 33 calls in the last 12 months – demonstrates need for public payphone.  Letchmore Heath is a small village, with only around 100 properties within 400m of payphone box – demonstrates possible concern about alternative access to telephone services.  Letchmore Heath village is close to Bhaktivedanta Manor religious establishment attracting many car-borne visitors to events who may require access to payphone.  Representations received
in response to the first notification requesting retention due to number of elderly people living in the settlement, this being their only means of emergency communication, long walk to alternative public phone, low maintenance cost, levels of use demonstrate need for payphone to remain.
