But after careful thought I now understood the thinking behind it as it disrupts the ability of a local office worker from parking here all day. Their ability to move the vehicle for those two hours would not be practical. I was won round by that idea. No waiting at any time proposal leaves nowhere for a family member or visiting tradesman to park for a one or two hour period. Personally I work from home full time as a bespoke tailor. Occasionally I have clients visiting for fittings, which on average takes less than an hour. Having a handful of single yellow line spaces would be perfect. Can I PLEASE suggest putting a single yellow line in the area I have marked in green on your map?
