NOTICE is given that the Hertsmere Borough Council, (pursuant to arrangements made with Hertfordshire County Council) proposes to make the above Orders under the Road Traffic Regulation Act 1984 to introduce waiting restrictions and parking places as specified in the schedules to this notice.

**SCHEDULE 2: - No waiting – Monday to Friday 1m to 2pm, in those sections of Road listed below and as set out in the order and accompanying plans** – Parts of Mountway, Manor Way, Rosary Court, Osborne Road, Church Road, Grange Road, Broadwater, Heath Road, Heath Close, Kerdistone Close, Green Meadow, Westwood Close, The Mount, Heath Drive, Potters Bar

**SCHEDULE 3: No waiting at any time to be revoked - in those sections of roads listed below and as set out in the order and accompanying plans** – Parts of Cedar Close, Potters Bar

**SCHEDULE 4: Residents & visitor parking places (Mondays to Fridays 1pm to 2pm)– In those sections of roads listed below and as set out in the order and accompanying plans.-** Cedar Close, Inglefield and Rosary Court.

Charges for permits will be as follows –

Residents Permits	First permit = £15, second = £30 (as conditions listed in article 10 of this order) A maximum of 2 permits according to Schedule 1 of this order. Duplicate Residents Permit	£15

Duplicate Exemption Permit	£10
