

**THE HERTSMERE BOROUGH COUNCIL (VARIOUS ROADS, NORTH  
POTTERS BAR) (RESTRICTION OF WAITING) ORDER 2014  
THE HERTSMERE BOROUGH COUNCIL (CEDAR CLOSE, INGLEFIELD  
AND ROSARY COURT, POTTERS BAR) (CONTROLLED PARKING ZONE)  
(PARKING PLACES) ORDER 2014**

NOTICE is hereby given that the Hertsmere Borough Council, (pursuant to arrangements made with Hertfordshire County Council) has made the above Orders under the Road Traffic Regulation Act 1984.

The general effect of the Orders will be to introduce Waiting Restrictions and parking places in parts of Potters Bar as specified in the Schedules to this Notice. The orders will come into effect on Friday 25 July 2014.

Any person wishing to question the validity of the Orders, or of any provision contained in them, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or any Instrument made under it has not been complied with in relation to the Orders, may within 6 weeks from the date of this Notice apply to the High Court for this purpose.
