THE HERTSMERE BOROUGH COUNCIL (VARIOUS ROADS, NORTH POTTERS BAR) (RESTRICTION OF WAITING)2014 (AMENDMENT No 1) ORDER 2015

Hertsmere Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2000 in exercise of the powers on the said County Council by Sections 1, 2, 3, 4, to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

1. This Order may be cited as "The Hertsmere Borough Council (Various Roads, North Potters Bar) (Restriction of waiting) 2014(Amendment No1) Order 2015 (hereinafter referred to as "this Order") and shall amend The Hertsmere Borough Council (Various Roads, North Potters Bar) (Restriction of Waiting) Order 2014 (herein after referred to as "the Order of 2014") and shall come into operation on 30th September 2015

Amendment

2. The Order of 2014 is hereby amended by the inclusion of items in Schedules 1 and 2 to this Order.

Revocation

3. The Order of 2014 is hereby amended by the removal of items in Schedule 3 and 4 to this Order.

Interpretation

4. The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into effect of this Order, The Order of 2014 shall have effect as though items in the schedules of this Order were added or removed from Schedules 1 and 2 of the 2015 Order.
6. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.

SCHEDULE 1

Various Roads, Potters Bar – No waiting at any time

| 1 | Church Road, South side | From a point approximately 10 metres west of the western kerbline of Sandringham Road eastwards for a distance of approximately 40 metres |
| 2 | Church Road, South side | From a point approximately 40 metres west of the western kerbline of junction with Sandringham Road westwards for a distance of approximately 6 metres |
| 3 | Church Road, South side | From a point approximately 3.5 metres west of the eastern boundary of property number 103 Church Road westwards for a distance of approximately 6 metres |
| 4 | Church Road, South side | From a point approximately in line with the western boundary of property number 93 Church Road westwards for a distance of approximately 8 metres |
| 5 | Church Road, South side | From a point approximately 4 metres east of the eastern boundary of property number 79 Church Road westwards for a distance of approximately 6 metres |
| 6 | Church Road, South side | From a point approximately 3 metres west of the western boundary of property number 79 Church Road westwards for a distance of approximately 5.5 metres |
| 7 | Church Road, South side | From a point approximately in line with the eastern boundary of property number 69 Church Road westwards for a distance of approximately 5 metres |
| 8 | Church Road, South side | From a point approximately 9 metres west of the western boundary of property number 59 Church Road westwards for a distance of approximately 3 metres |
| 9 | Church Road, South side | From a point approximately 27 metres west of the western boundary of property number 59 Church Road westwards for a distance of approximately 21 metres |
| 10 | Heath Road, North side | From a point in line with the eastern kerbline of Heath Road junction with Kerdistone Close eastwards for a distance of approximately 30 metres |

Various Roads, Potters Bar - No waiting 1.00 pm to 2.00 pm Monday to Friday

| No. | Street Name | Line Description |

| 1 | Grangewood , North side | From a point 10 metres east of the northern kerb line of junction with Osborne Road eastwards for a distance of approximately 20 metres |
| 2 | Osborne Road, West side | From a point approximately 26 metres south of the southern kerbline of junction with Heath Road, southwards for a distance of approximately 61 metres |

Various Roads, Potters Bar – No waiting at any time to be revoked

| No. | Street Name | Line Description |
|------------|-----------------------------|---|
| 1 | Church Road, south side | From a point approximately 12 metres east of the junction with Quakers Lane, eastwards for a distance of approximately 38 metres |
| 2 | Heath Road, south side | From a point in line with the southern kerblines of Heath Road junction with Osborne Road westwards for a distance of 60 metres |
| 3 | Heath Road, north side | From a point in line with the common boundary between 61 and 63 Heath Road westwards for a distance of 27 metres |
| 4 | Heath Road, north side | From a point 1metre east of the western boundary of property number 55 Heath Road westwards to the eastern kerb line of Kerdistone Close |
| 5 | Heath Close, both sides | From a point in line with the northern kerblines of Heath Road northwards for a distance of 10 metres. |
| 6 | Kerdistone Close, east side | From a point in line with the northern kerb line of Heath Road northwards for a distance of 10 metres. |
| 7 | Osborne Road, west side | From a point 11 metres north of the northern kerblines of junction with Heath Road southwards to a point 13metres south of a point in line with the southern kerblines of Heath Road. |
| 8 | Osborne Road east side | From a point in line with the Northern boundary of property number 26 Osborne Road northwards for a distance of 25 metres. |



|------------|-------------------------|--|
| 1 | Grangewood, North side | From a point approximately 10 metres west of the northern kerblines of junction with Osborne Road westwards for a distance of approximately 9 metres |
| 2 | Osborne Road, West side | From a point 13 metres south of the southern kerblines of junction with Heath Road southwards for a distance of 75 metres. |
