**THE HERTSMERE BOROUGH COUNCIL (KEMP PLACE AND MONTAGUE HALL PLACE BUSHEY) (RESTRICTION OF WAITING) ORDER 2020 (AMENDMENT No.1) ORDER 2024**

Hertsmere Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Authorities (Arrangements for Discharge of Functions) (England) Regulations 2000 in exercise of the powers on the said County Council by Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

1. This Order may be cited as "The Hertsmere Borough Council (Kemp Place and Montague Hall Place, Bushey) (Restriction of Waiting) Order 2020 (Amendment No.1) Order 2024" hereinafter referred to as "the 2020 Order" and shall come into operation 2<sup>nd</sup> September 2024
2. The Hertsmere Borough Council (Kemp Place and Montague Hall Place, Bushey) (Restriction of Waiting) Order 2020 shall be amended in accordance with Articles 3 to 4 to this Order.
3. The sides of road referred to in the Schedule 1 to this Order shall be added to the Schedule 1 of the 2020 Order as are indicated in Schedule to this Order.
4. The sides of road referred to in the Schedule 2 to this Order shall be deleted from the Schedule 1 of the 2020 Order as are indicated in Schedule 2 to this Order.
5. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

### SCHEDULE 1

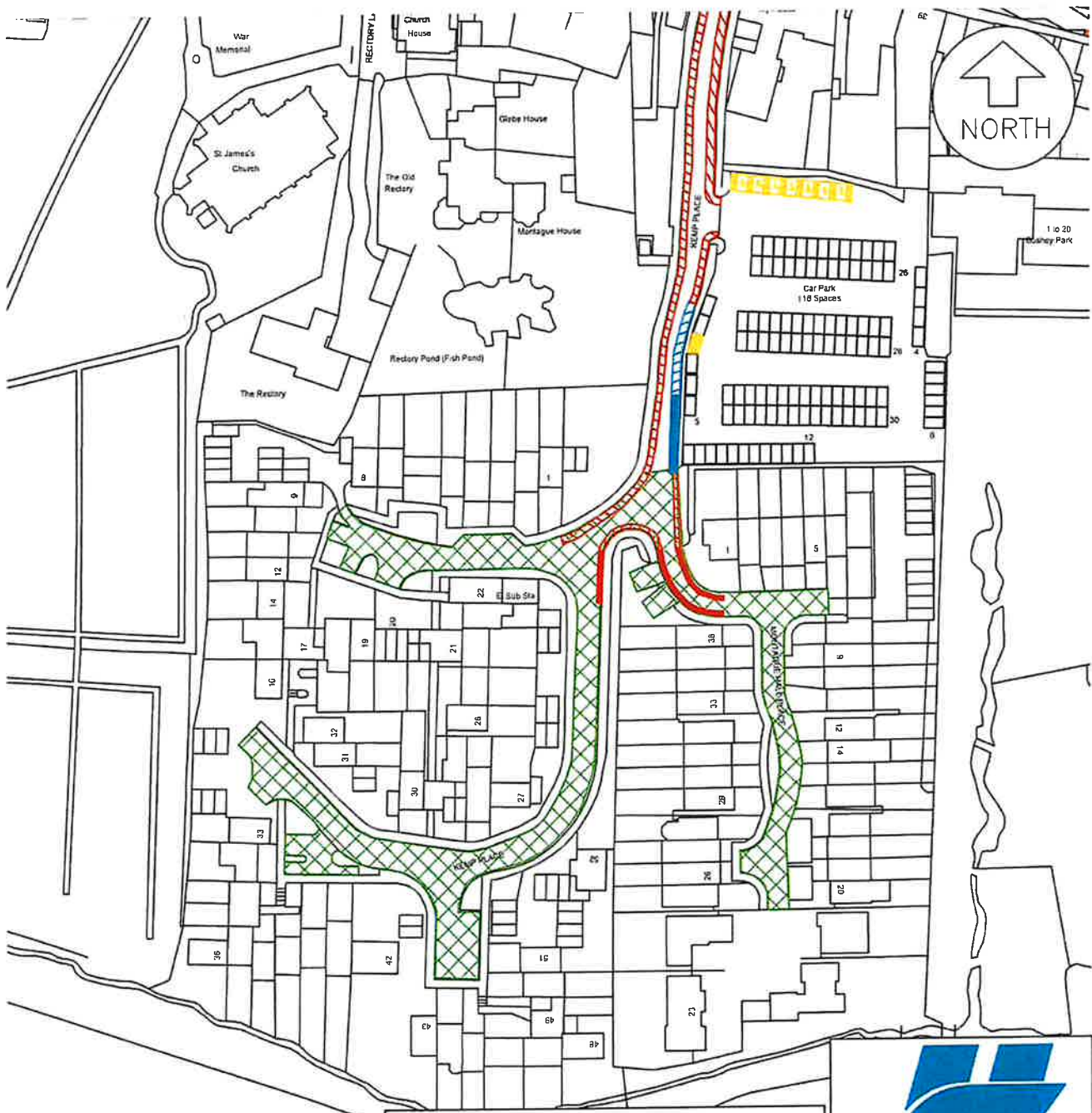
#### NO WAITING AT ANYTIME

Location	Description
Kemp Place (west side)	From a point in line with the eastern flank wall of number 1 Kemp Place northwards for distance of 94 metres
Kemp Place (east side)	From a point in line western flank wall of number 1 Montague Hall Place northwards for a distance of 30 metres
Montague Hall Place (south)	From a point in line with the northern flank wall of number 36 Montague Hall Place northwards then southwards for a distance of 50 metres






### SCHEDULE 2

#### NO WAITING AT ANYTIME

Location	Description
Kemp Place (west side)	From a point in line with the eastern flank wall of number 1 Kemp Place northwards for distance of 94 metres
Kemp Place (east side)	From a point in line with the southern kerblines of Montague Hall Place northwards for distance of 31 metres
Montague Hall Place (west side)	From a point in line with the southwestern kerblines of Montague Hall Place westwards for a distance of 17.5 metres
