(FIRS LANE, HIGHVIEW GARDENS AND HOLLY DRIVE, POTTERS BAR)
(RESTRICTION OF WAITING and REVOCATION) ORDER 2017**

NOTICE is given that the Hertsmere Borough Council, (pursuant to arrangements made with Hertfordshire County Council) proposes to make the above named Orders under the Road Traffic Regulation Act 1984 to introduce parking changes in Ashwood Road, Barnet Road, Firs Lane, Highview Gardens, Holly Drive and Mutton Lane, Potters Bar.

The general effect of the Orders will be:

- To remove an unused disabled parking bay and replace it with a residents permit holders bay in Ashwood Road
- To change a Pay & Display parking bay into a resident and visitor permit holders parking bay in Barnet Road
- to alter the restriction times of residents permit parking bays from one hour to all day in Firs Lane and Holly Drive
- to change single yellow line restrictions from one hour to all day in Firs Lane and Holly Drive
- to change residents and visitors permit holders parking bay into permit holders parking bay in Mutton Lane.
- To remove a parking bay which is partially obstructing driveways in Highview Gardens and replace it with a single yellow line.

SCHEDULE 1: Residents & visitor parking places – In those sections of roads set out in the Order and accompanying plans:

Ashwood Road, Barnet Road, Firs Lane, Holly Drive and Mutton Lane, Potters Bar

Charges for permits will be as follows –

Residents Permits	First permit = £25, second = £40, third = £70, fourth = £100 (as conditions listed in article 10 of the Order). A maximum of 4 permits according to Schedule 1 of the Order
Duplicate Residents Permit	£15
Visitors Parking Vouchers	£5 per 20 half-day vouchers
Visitors Annual Permits	£40
Business Parking Permit	12 months - £400 six months - £230 three months - £120
Exemption Permits	Free of charge
Duplicate Exemption Permit	£10
