These comments relate specifically to the Paddock in Elstree Road, Bushey Heath, opposite Reveley Lodge (site reference BH007):-

5(b) (Not justified): Designating the Paddock a Local Green Space is not the most appropriate strategy, because it does not have historical, local or cultural significance. Additionally, designation would jeopardise (by preventing development) the future of Reveley Lodge, which does have all of these connections.

5(d) (Not consistent with National Policy): The Paddock does not meet any of the three reasons given for a designation in paragraph 77 of the National Policy.

Two alternative suggestions, if a Local Green Space is desired in this location:

A): Designate Reveley Lodge's garden a Local Green Space, rather than the Paddock. Its area is similar; it does have historic local connections, and is a community asset. And allow suitable development on the Paddock.

B): If the Paddock has to be a Local Green Space, make its designation conditional on the Paddock being bought, for a fair commercial price, by Hertsmere, or Bushey Heath Residents Association, or by public subscription.

Either of these suggestions would provide a Local Green Space, protect the future of Reveley Lodge (by funding repairs and maintenance), and honour the wishes of Mrs Chewett, who gave the property to the community.
