### **Site Allocations and Development Management Policies Plan Town and Country Planning (Local Planning) (England) Regulations 2012**

I am writing to inform you of the publication of the Council's Site Allocations and Development Management Policies Plan (SADM for short) in accordance with the above regulations.

Publication of SADM follows the adoption of the Council's Core Strategy in 2013 which set out how future housing and other development needs will be accommodated over the next 15 years. The SADM Policies Plan proposes specific development sites and designations, along with detailed environmental criteria against which future planning applications across the borough will be considered. The SADM Policies Plan has also been approved for interim use in the determination of applications on or after the date of publication of the Plan (31<sup>st</sup> July 2015).

Publication of the SADM Policies Plan follows a public consultation in 2014 on a draft Plan and a series of changes have been made following careful consideration of the representations made. There will now be a six week period in which comments can be made on the published Plan ahead of a public examination which will be held by an independent Inspector. This period runs from **Monday 3 August 2015 until 5pm on Monday 14<sup>th</sup> September**. All representations received over the next six weeks will be considered by the Inspector and there will be a public hearing where interested parties may be invited to appear in person.

As well as contacting people who have requested to be notified on new planning documents, the Council is also notifying people who live or work near to some of the sites which are identified in the document, some of which may come forward for development in the future. Both the published Plan and a number of supporting documents can be viewed on the Council’s website at [www.hertsmere.gov.uk/sadm](http://www.hertsmere.gov.uk/sadm) as well as at local libraries, the Civic Offices in Borehamwood and local area offices in Potters Bar and Bushey. Details of their opening times are set out below.

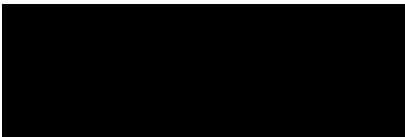
