The councils online map that you are viewing is the most up to date version of the working Definitive Map (DM), the paper copies of the legal DM are nearly 7 years old. None of the paths you have mentioned have been changed since 1960, so both maps should match. The only difference is the lines a finer of the digital mapping.

No appointment is needed just ask at the front desk to see the DM and photos are allowed but not for commercial use.

County Hall has several Post Codes, you will need the front reception which faces Pegs Lane.

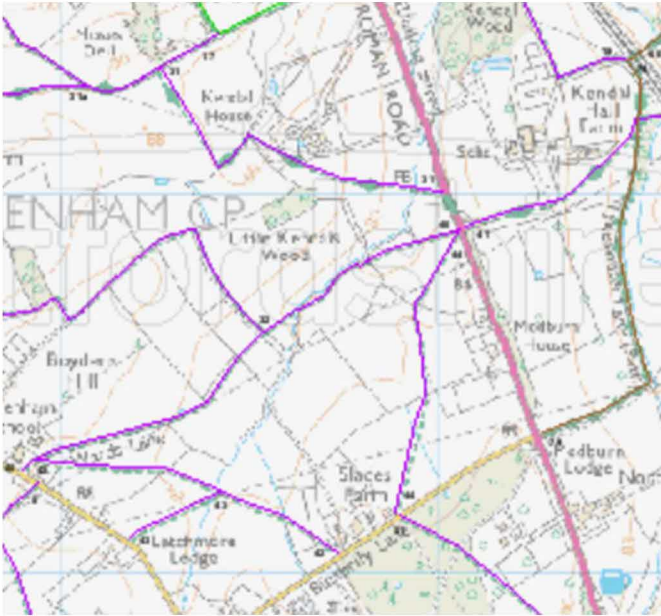
